Location: 3 Hunts Cottages Church Street Thornham Hunstanton Norfolk Object to the application - It is out of character, not in keeping with the surrounding area and overbearing. This is contrary to the Neighbourhood Plan: H5: Residential extensions.

The split travels through the other side of the limb. remove limb due to within falling distance of the main drive. T2 (tag 17) Ash - Large elongated limb facing South East subject to limb failure due to excessive length / weight. Suggest reducing limb by 3.5 - 4m back into the drooping growth and bringing it in line with the rest of the canopy TPO Work Approved 26 February 2024 Delegated Decision
